TUITION & FEE SCHEDULE

2019 -2020 School Year

Solid Foundation Preparatory Academy labors to provide an excellent private academic program and endeavors to ensure affordability for the families who choose to attend the school. Listed below are the tuition and fees for the 2019-2020 school year.

Book and Material Fees (non-refundable)

(Deadline April 15, 2019)

Returning Students:

PreK4 – 1 st	\$200.00
2 nd – 5 th Grade	\$250.00

New Students:

PreK3 – 1 st	\$250.00
2 nd – 5 th Grade	\$300.00

Tuition for 2019 – 2020 School Year

Tuition payments are due on the 1st of each month.

A \$50.00 late fee is assessed on the 3rd day of the month.

Monthly payments can be made through ACH withdrawal.

PreK3 – PreK4 (\$5,648)

\$5,084.00/yearly	(10% discount if paid in full by June 1, 2019)
\$2,683.00/per semester	(5% discount if paid ½ by June 1 st and ½ by December 1 st)
\$470.00/monthly	(12 payments / 1 st payment due June 1 st)

Kindergarten – 5th Grade (\$5,289)

\$4,761.00/yearly	(10% discount if paid in full by June 1, 2019)
\$2,776.50/per semester	(5% discount if paid ½ by June 1 st and ½ by December 1 st)
\$440.00/monthly	(12 payments / 1 st payment due June 1 st)

After-Care Fees: (After-Care hours are 4:00pm – 5:30pm)

\$30 weekly fee paid in advance	\$25 per week (2 nd child)
\$10 daily fee paid the day services are rendered	\$5 per day (2 nd child)

Other Fees:

Field Trip and Lunch fees vary from (\$15.00 - \$65.00). Lunch Fees vary depending on the month.

I further understand that all other payments begin June 1, 2019. **I further understand that if my child withdraws from school for any reason on or after June 1, 2019, I am still responsible for the full tuition for the entire 2019-2020 school year.**

I understand that Solid Foundation Preparatory Academy will pursue all available collection methods for unpaid bills, and the expenses of such collections, including but not limited to reasonable attorney fees, will be added to the unpaid balance.

I understand that all school bills must be paid in full before student records/transcripts will be released.

I agree to make no claim for refunds of tuition, fees, or other charges on account of extended absence or dismissal of the student.

I further agree to abide by all rules, regulations, and disciplinary procedures deemed necessary for the proper operation of the school. I also understand that my child/legal dependent will be held accountable by these same rules, regulations, and procedures, as they are contained in the annual Parent/Student Handbook.

All payments begin June 1, 2019.

All subsequent payments are due by the first of each month. **Payments are considered late by the 3rd of the month.** A \$50.00 late fee will be charged on the 3rd of the month for any unpaid balances.

There is a 10% discount for siblings in grades Kindergarten through 5th Grade only. Note: Only one discount may be utilized for tuition and fees.

Each family is assessed an \$800 fundraising requirement. Parents may raise the assessment through the various fundraisers offered by SFPA. The fundraising events include, but not limited to, Blue and Gold sales, A Brass and Sassy Affair Events, company matching programs and/or general donations. In the event the requested \$800 is not met, student accounts will be invoiced for the remaining amount.

Book and Material Fee (non-refundable) is due April 15, 2019.
